

**THE 2022 TRULY VODKA TRAVEL SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

The 2022 Truly Vodka Travel Sweepstakes ("Sweepstakes") is sponsored by Jim Beam Brands Co. ("Sponsor"), 222 W. Merchandise Mart Plaza, Suite 1600, Chicago IL 60654 and is administered by Prize Logic, LLC, ("Administrator"), Two Towne Square, Suite 200, Southfield, MI 48076.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on March 21, 2022 at 12:00 PM Eastern Time ("E") and ends on August 31, 2022 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of Alabama, Arkansas, Colorado, Connecticut, Delaware, Florida, Idaho, Iowa, Illinois, Indiana Kansas, Kentucky, Louisiana, Maine, Massachusetts, Michigan, Minnesota, Missouri, Mississippi, Montana, New Hampshire, New Jersey, New York, Ohio, Oklahoma, Oregon, Pennsylvania, Rhode Island, Texas, Vermont, Wisconsin, and Wyoming who are at least twenty-one (21) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. Employees, agents and officers of alcohol beverage retailers and distributors and their immediate family members and all other individuals/entities associated with this Sweepstakes are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

The content included in the Entry will not be judged or used in any way to determine a winner. By entering the Sweepstakes and using the hashtag “#TrulyVodkaSweepstakes”, (and the Pool Hashtag for eligible entrants) entrant hereby agrees to be bound by these Official Rules. Entries will be deemed made by the authorized account holder of the Twitter account the entry is submitted from at the time of entry. The “authorized account holder” is the person who is assigned to the Twitter account by the online service provider. An entrant must have a non-private Twitter account to enter the Sweepstakes and must be a follower of @TrulySeltzer on Twitter until October 1, 2022 for potential winner notification purposes to be eligible to win/claim a prize. - Entry must not include any personally identifiable information (full name, e-mail address, telephone number, etc.);
- Entry must not contain, facilitate, reference or use material that contains prohibited content which shall include, but is not limited to, content that promotes, suggests, or encourages:

If any Entry fails to comply with any of these Entry Requirements or any other provisions of these Official Rules, at the Sponsor's sole discretion, Sponsor reserves the right to disqualify the entrant.

Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

**5. PRIZES, APPROXIMATE RETAIL VALUES ("ARV"), AND ODDS OF WINNING:**

**A. National Sweepstakes Prize (1):** The National Sweepstakes prize is \$10,000 ("National Sweepstakes Prize"). No more than one (1) National Sweepstakes Prize will be available in the Sweepstakes. The ARV of the National Sweepstakes Prize is \$10,000.

**B. Pool Prizes (6 total; 1 per Pool):** Each Pool prize is \$10,000 (each a "Pool Prize"). No more than six (6) Pool Prizes, one (1) per Pool, will be available in the Sweepstakes. The ARV of each Pool Prize is \$10,000.

**C. Total ARV:** The total ARV of all prizes is \$60,000.

**D. Odds of Winning:** The odds of winning the National Sweepstakes Prize depend on the number of eligible Sweepstakes entries received in the National Sweepstakes during the Sweepstakes Period and the odds of winning a Pool Prize depend on the number of eligible Sweepstakes entries received in each respective Pool during the Sweepstakes Period.

**E. General Conditions:** There is a limit of one (1) prize per person. In no event will more than one (1) National Sweepstakes Prize and six (6) Pool Prizes, one (1) per Pool, be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received. **NO ALCOHOL WILL BE AWARDED AS PART OF ANY PRIZE.**

If, for any reason, more prize notifications are sent (or more claims are received) than the prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the stated number of prizes through a random drawing from among all eligible prize claims received. The potential winners will be notified on Twitter by a Direct Message from @TrulySeltzer with instructions on how to claim his/her prize. The potential winners must respond to Twitter Direct Message winner notification within twenty-four (24) hours or they may, at the Sponsor's sole discretion, be disqualified. Potential winners will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where

prohibited) and any other requested documents within five (5) business days from the date of attempted notification or the prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. The prizes will only be awarded to a verified winner.
